Loan Terms

Loan amounts starting from \$2,500

Fixed interest rate of 2.45% and interest only payments for the first year

Repayable anytime in part or in full without penalty

The Application Process

Submit your <u>completed</u> loan package to Enterprise Brant. Documentation Required Where Applicable

- 1. Client Information Form and Waiver of Liability must be completed in order to work with a consultant
- 2. Business Plan including the use of the additional funding
- **3. 12-Month Cash Flow Forecast** an Excel template is available on our website-see the Cash Flow Forecast Tool
- 4. Identification two pieces of identification one must be government ID with a current photo. (Health Cards are not acceptable)
- 5. Taxation
 - ➤ Personal CRA Notice of Assessment for 2020
 - Corporate Notice of Assessment
 - Current Statement of Government Remittances
- **6. Resume** provide resume for each owner
- 7. Existing Businesses
 - ➤ Annual Financial Statements Most recent complete accountant prepared financial statements and the most current internal interim financial statements including:
 - Profit and Loss (Income Statement)
 - ➤ Balance Sheet
 - > Accounts Receivable aged lists
 - > Accounts Payable aged lists
 - Sole Proprietorship/Partnership copy of your Master Business License
 - Partnership copy of your partnership agreement
 - Corporation copy of the Articles of Incorporation including Borrowing Bylaws.
 - > Shareholder Register & Officers Certificate
- 8. Completed Personal Financial Statement
 - Recent Pay Stub if applicable
- 9. Signed and Completed Loan Application Form

Once we have all your documents, credit and reference checks will be completed and information requiring clarification will be discussed. Additional information may be required once the initial review of your application is completed.

Criteria for Loan Consideration

Specific financing criteria must be met including:

- Application to be submitted by October 31, 2021.
- ➤ The business must be based in Brant/Brantford.
- > Reasonable personal financial investment
- > Good personal credit rating
- > Demonstrated ability to repay.
- > Future economic viability of the business
- > Competent management

Approved Applications

Upon approval we will prepare an Offer to Finance that you must sign and return within a prescribed period of time. Loan documentation will then be prepared for signing.

Processing of Your Application and Acceptance of Our Offer

You will be responsible for administration or legal fees and the loan application fee. The fees can vary depending on the registrations and the complexity of the security involved. The application fee is 1% of the loan amount, minimum \$100 to a maximum of \$1,500.

- 2. **Declined**: application declined You will be advised by email with an explanation, and you will have the opportunity to address any concerns and re-submit your application
- 3. **Request for additional information** additional information required for approval.
